### **ACCEPT YOUR INVITATION**

Do not wait to accept your invitation! Use the link below to review your session details and accept or decline your invitation. Exact presentation times will be sent in October. You should plan to attend the entire session.

You must accept or decline your presentation no later than August 26, 2024 at 11:00 PM Eastern Daylight Time. If you have submitted more than one abstract, you will receive multiple invitations and will need to accept or decline each one.

**Important Note for Oral Presentations:** All presenters must provide their own laptops onsite.

**Important Note for Poster Presentations:** All poster presenter changes must be requested no later than Thursday, Nov. 21, 2024. If a change in the onsite presenter is necessary for a particular poster, ONLY those listed as co-authors of the poster will be eligible to act as an alternate presenter. If this poster is chosen for a Best Poster Award, the award prize check will be made out in the name of the onsite presenter, NOT the original presenter. To be recognized as a Best Poster winner, the presenter must be registered, be onsite and be the one responsible for presenting the poster in Boston.

### **REGISTRATION**

**ALL presenters**, including invited speakers, must register for the meeting in order to present. Registration information can be found on the MRS website [registration page](#). Register before September 26, 2024 at 11:59 pm ET for the lowest price on registration!
